Term fees are due STRICTLY between weeks 1-5. Fees are calculated according to the NSW Public School Terms. Term fees include regular classes, stickers, rewards and prizes at our Annual Trophy Presentation and Awards Day for every student.

All late fees will incur a 10% surcharge – this includes part payments. Only fees paid in full by WEEK 5 of any one Term will be charged at the rates quoted. A family discount of 10% applies to the second child and 15% for the third child's term fees. Any other costs are to be paid in full.

**All fees, once paid, are non-refundable and Non-transferable.
Fee payments are to be completed by Week 5 of EACH term.**

***All private lessons booked must be paid for in advance to your teacher.
No credit is ever given for missed classes.***

Unpaid accounts will be reported to the Credit Reference Association.

Terms & Conditions:

Parents are responsible for their child's behaviour and their safety whilst on our premises, including parking lots, bathrooms, waiting areas etc. I understand that **children are not allowed in the studio classrooms when not participating in the class that is in progress** unless they have been given permission to practice a routine.

All troupe dances remain the sole property of Avenue T Dance Academy and may not be reproduced or performed outside the studio without prior permission.

Fees are required in advance for all classes. The final decision on all school proceedings and related activities rests with the Owner of Avenue T Dance Academy.

Please be advised that all care will be taken to ensure that your child does not sustain any injuries during the course of any class. Avenue T Dance Academy Rules and Guidelines have been formulated with everyone's safety in mind. The rules of the school are designed to promote discipline and professionalism and must be abided by. No responsibility will be accepted for any accident or injury sustained during any class conducted by any of our choreographers/tutors. Our choreographers have been fully trained in Safe Dance Practices and currently have Working with Children clearance.

Children left at the studio for any length of time after their class or for any length of time prior to their scheduled timetable class are not covered by our insurance. We do not hold insurance for child care or child sitting hence please be punctual in dropping students of and picking up. If you are going to be late picking your child/children up, please contact us. If you are late without notice by more than 15 minutes a fee of \$35.00 per half hour pro-rata will apply and be invoiced to you.
